State Department Reports

MDHHS – MDHHS Laura de la Rambelje

- Governor's recommendation to increase ELPHS funding by \$30 million to \$51 million.
- Executive Directive 9 will see pieces of this in the Governor's budget proposal some one-time funding, ELPHS, drinking water mention does not address ED9.
 - Has asked for copy of report but hasn't received it yet. Will share once approval has been received.
- CDC Infrastructure Grant in supplemental and could be introduced anytime now. Ready
 to go but can't release until appropriated and know what activities can be done with
 funding.

Medicaid Hospital and Clinic Reimbursement Division – MDHHS – Tammy Stevens/Steve Ireland

- 9/30 fiscal year end if need extension, file now.
- Working on FY21 settlements.
- Had meeting with Health Plans re: MIHP, terms accepted but some doubts expressed after meeting so no letter has been sent out yet. This should be cleared up soon and a letter sent.

LMCH/Medicaid Outreach - MDHHS - Trudy Esch

- Medicaid Outreach Training at 1:00 pm on 2/22/23 for anybody who wants to go but geared towards new staff.
- LMCH allocation and expenditures:
 - 30% funding for prevention and primary care is within LMCH grant activities.
 This was not met in FY22 the amount spent with this funding was 27.6%. This is below the 30% required and cannot happen in FY23 or future years.
 - o In FY24, can LHD's not allocating to MCH Children consider doing so?
 - FY23 Q1 FSR's show MCH Children spending at 5% instead of the expected 25%.
 Letters have been sent to those LHD's that are below the 25%.
 - What can be done in FY23 so this is not repeated.

<u>Bureau of Audit</u> – MDHHS – Shannah Havens

FEMA COIVID Immunization:

- Have numbers that will go into the formula calculation. Will get FY23 funding letter within the next 10 days.
- All JV's will be entered by 2/28/23. Can then pull FFA information in EGrAMS after 3/2/23.
- FEMA Immunization expenditures are on the conservative side and what LHD might have as a FEMA number might be more that what was really used.
- o \$14.4 million in COVID Immunization expenditures transferred to FEMA.
