SUBJECT: MDARD / MDHHS Epi Ready Foodborne Disease Outbreak Team Training

The Michigan Department of Agriculture and Rural Development (MDARD), Human Food Division, and the Michigan Department of Health and Human Services (DHHS), Division of Communicable Diseases have scheduled an Epi-Ready Foodborne Disease Outbreak Team Training to take place on **October 22 & 23**, **2024** at Northern Michigan University 1401 Presque Isle, Marquette, MI 49855.

### **Course Description**

The intention of this two-day workshop is to train public health professionals and other involved personnel to rapidly identify and investigate a foodborne disease outbreak to allow for (1) swift implementation of control measures to stop the outbreak and (2) prevent future similar outbreaks. This course promotes highly trained epidemiology, laboratory, and environmental health workforces skilled in properly conducting foodborne illness investigations. Topics are covered through a combination of lecture, question and answer sessions, interactive group exercises, and final case study.

# **Participant Guidelines**

This training is focused for public health professionals with one to four (1-4) years of on-the-job experience involved in outbreak investigations including: environmental health specialists/sanitarians, epidemiologists, infectious disease control staff, public health nurses, laboratorians, emergency preparedness coordinators, and others. *The maximum number of participants is 35-40 per session.* **Participants who reside in the northern lower peninsula and upper peninsula will be given priority.** 

#### Cost

There is no charge for this course. Continuing education credits in the areas of Nursing (14.0), CPH (14.0), and CHES (14.0) are available. Additionally, you may apply for contact hours through NEHA upon completion of this course.
