Notes:

- "Assured" = National resettlement agencies have asked local resettlement agencies (1st column, affiliate) to confirm a number to take. Affiliates have about 24 hours to confirm/deny this number or propose a new one. With the Afghan arrival process there is no set length of time between a number being assured and those people arriving in the state. National agencies and the federal government are trying to make it within one week, however there have been delays. For the purposes of this communication, use the assured number as the estimated number of arrivals within the following 14 days.
- "In Transit" = The client's travel has been booked and they are either about to leave the base or are in the process of physically traveling between the base and their destination. Based on previous data, the in-transit process (from booking to arrival) takes about 7 days.
- "Arrived" = The number of clients who have arrived at their destination, reported by the resettlement agency. This number may be different from federal reports because it includes walk-ins who were not processed at the bases, and it excludes clients who chose to leave after arrival. The arrived number counts towards the "Proposed to Resettle" (second column) number.
- Wayne, Oakland, and Macomb Counties: The affiliates resettling in these counties have not proposed an estimated number of people being resettled for each county.
