HOW WE CAN HELP.

Homeowners and Rental Property Owners in: Flint and Detroit

- Medicaid enrollee under the age of 19 or pregnant female living in home
- Other low-income households with a child under the age of 6 or a pregnantemale living in home

• Low-income households with a child under the age of 6 or a pregnant female living in home

Statewide

•Medicaid or low-income households with a child under the age of 6 with elevated blood lead level of 5 µg/dL or higher
