Report Writing training courses are available upon request

This training focuses on report writing techniques that aid in meeting Accreditation Minimum Program Requirements as well as best practices in writing a clear, factual, and legally defensible evaluation report. It consists of a speaker presentation followed by tabletop exercises. It is designed to be a half-day training course but can be adjusted to meet the needs of your department.
